VRU (Pedestrian + Bicycle + 2W)

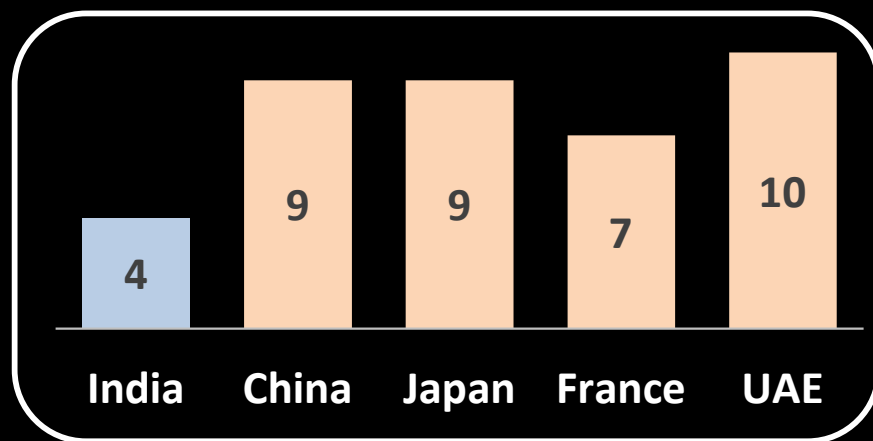
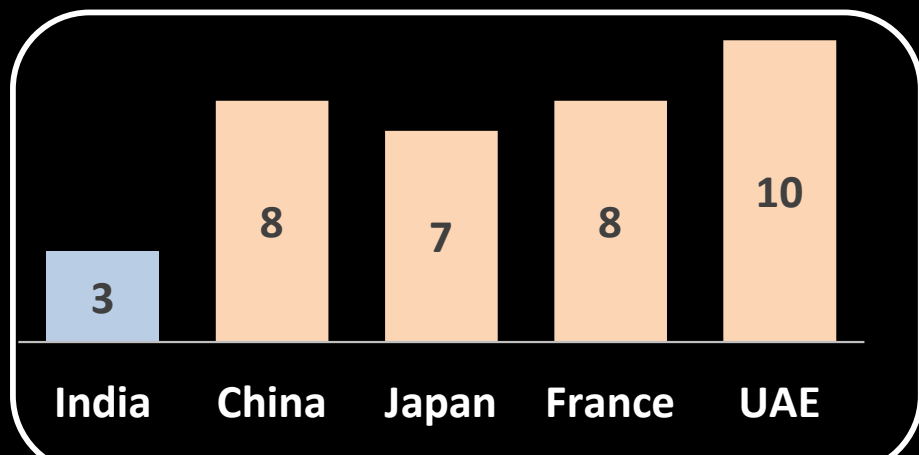


1. In **~87%** of fatalities in 4-wheelers, Seat-Belts were not worn.
2. In **70%** of fatalities in 2-wheelers, Helmets were not worn.
3. **~68%** of the fatalities are due to over-speeding.

**In metropolitan cities, the Vulnerable Road Users (VRUs) accounts for as high as 89%**

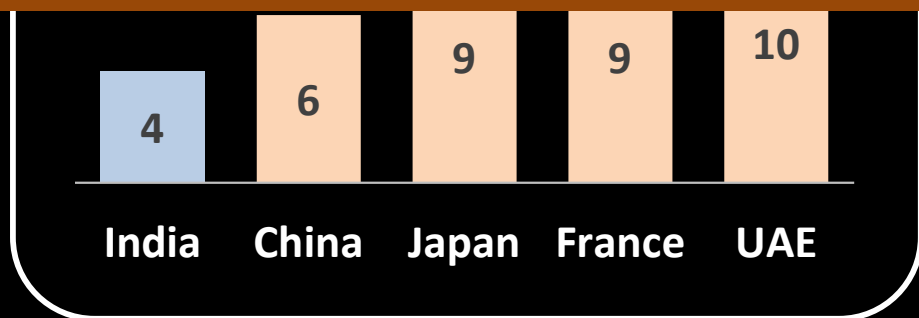
